Protocol Directorate of the Foreign and Commonwealth Office presents its compliments to all diplomatic missions and has the honour to refer to the procedure for applying for refund of VAT and duty on purchases of petrol, diesel and heating oil.

The Directorate wishes to remind missions that the new Form 10 has replaced the TX10 and TX10(priv) forms, and that all claims for fuel tax refund, both for private and official vehicles, must now be submitted using the new form.

The Directorate further wishes to remind missions that only claims for refund of fuel tax for vehicles with diplomatic or consular registration will be accepted, unless otherwise agreed in advance by the Directorate.

The Directorate requests that Form 10 be completed in the same format as shown on the enclosed example. Claims received that are not set out in this format, along with any claims containing ineligible vehicles, purchases not attributed to an entitled mission or official, or with insufficient evidence of purchase, will be returned to the mission.
